

LIABILITY COVER

Cover Provided

In consideration of the premium paid hereon; International Insurance Company of Hannover Limited (called here and after the Underwriters) will indemnify the Insured against liability at law for Damage and claimant's cost and expenses in respect of accidental:

- 1) Death, bodily injury, illness or disease of any person entitled to cover under this insurance:
- 2) Loss of, or Damage to, material Property which occurs anywhere in the United Kingdom, Channel Isles or Isle of Man during the Period of Insurance and is caused by, or arises in connection with any animal(s), Business, occupation or activities described in this Schedule.

The Underwriters liability for Damages under this Section shall not exceed the amount stated in the Schedule in respect of any one occurrence.

Costs

The Underwriters will also pay all costs and expenses incurred with their written consent and relating to any claim which may be the subject of indemnity under this insurance. If payment in Excess of the amount of indemnity available under this Section is made to dispose of a claim, then the Underwriters liability for costs and expenses will be limited to the proportion that the indemnity hereunder bears to the claim payment.
